Terms and Conditions For Exhibit Space

Capacity Control

The policy of controlling the number of exhibitor's selling/ displaying at each show will continue throughout the year. An early reservation with full payment is important. To ensure your spot, **a down payment of half of your cost is due by April 15, 2021. Complete payment is due by June 30, 2021**, unless other arrangements have been made with Rally Management. **Returned check fee is \$50.00 plus any other bank or collection charges incurred. All Vendor Payments are nonrefundable. You will not be allowed to set up, if full payment has NOT been made.**

Booth Space Assignment

All booth assignments will be given at the time of exhibitor check-in and are based on a first paid, first reserved basis. Booth location is also determined by how long you have been a vendor at the Kentucky Bike Rally and the size of your booth. Management will work with you as best we can to honor your space request. Kentucky Bike Rally does not guarantee preferred booth locations. Special circumstances require management discretion. Exhibitors **MUST** keep within their paid, designated booth space. Your product, signage and setup **MUST BE** inside your assigned space. There will be designated free parking for vendors outside of Gate 1. Show Management has the right to request your removal at any time.

Setup/Teardown Policy

Setup time will begin Monday July 12, 2021 from 9:00 AM to 9:00 PM, Tuesday July 13, 2021 9:00 AM to 9:00 PM, and Wednesday July 14, 2021 9:00 AM until 12:00 PM, after this the rally will be open and we will not allow any more vendors to enter. We offer Early Bird to our patrons Wednesday July 14, 2021. They enter the campgrounds at 10:00 am. We ask that you are in your spot and set up to run by this time. No early teardowns without Management approval. **If space is not cleaned and all trash removed when you depart you will not be asked to come back in following years.**

Vendor Replenishment

Replenishment hours are in the morning from **7:00 AM to 10:00 AM**, and nightly from **11:00 PM to 7:00 AM**. Please replenish your stock at this set time. Vehicles must not be left in motorcycle parking areas. There is designated parking outside Gate 1. Paid vehicles will only be asked to park in free vendor parking if found entering or exiting during non-replenishment hours. All vehicles left inside without a vendor sticker and specified spot upon arrival will be towed at owner's expense. Each vendor will receive a vendor sticker for paid vehicles, which may go in and out during replenishment times only. No traffic flow will be allowed in or out of gates before or after these times.
